In 2022, Dauphin County went Blue and helped elect John Fetterman as our U.S. Senator, Josh Shapiro/Austin Davis as Governor/Lt. Governor. Our additional wins in Dauphin County for state representative helped the House Democrats gain the majority. These interviews serve as our best effort to present the voters with the most viable candidates while strengthening the potential of electing qualified Democratic candidates and uniting our Democratic Party in Dauphin County behind one candidate for each ballot position.

PLEASE NOTE: any candidate seeking the endorsement from DCDC must go through our endorsement process per our rules.

The DCDC's annual Nomination Petition Training will take place **Tuesday**, **January 16**, **2024**. The training will be conducted by the Dauphin County Elections Office. Blank petition forms and walking lists for your volunteers will be available to pick up if needed. Our endorsement meeting will take place on **Saturday**, **February 17**, **2024**. Additional details are forthcoming.
